In the event THE CLIENT fails to provide any of the above, and the DJ's performance is thereby delayed or prevented, PORTA PARTY DJ's shall have no liability to THE CLIENT to refund any amounts paid to PORTA PARTY DJ's hereunder.

In the event that PORTA PARTY DJ's is unable to perform for the entire period of time agreed hereunder due to either travel, equipment or other unforeseen difficulty within the maintenance and control of PORTA PARTY DJ's, PORTA PARTY DJ's' liability is limited to providing THE CLIENT with, at PORTA PARTY DJ's sole discretion, either:

- A. Compensation performance time equal to the time lost; or
- B. A cash refund prorated for the time period the DJ did not perform as it relates to the period of time that PORTA PARTY DJ's agrees hereunder to provide a DJ.

In any event, THE CLIENT shall pay for any portion of time that the PORTA PARTY DJ's DJ does perform.

PORTA PARTY DJ's shall not be liable for any injuries to THE CLIENT or its guests, and THE CLIENT agrees to indemnify and hold PORTA PARTY DJ's harmless for any claims made against it for any such injuries.
